On November 27, RI President Barry Rassin presented the

Polio Eradication Champion Award to UK Prime Minister Theresa May for her exemplary leadership role in driving the cause of polio eradication. In 2017 the UK pledged \$130M (USD) to the Global Polio Eradication Initiative (GPEI) for 2017-2017. So far the country's total contribution is \$1.6B (USD), the second highest amount from a G7 donor. This award was established in 1996 to honor heads of state and other individuals who have played an instrumental role .
