Today's Speaker: Peter and Christopher Loffler Polio Immunization in India



Peter Loffler is a registered patent attorney with over 25 years of patent application preparation experience. He has filed over 900 patent applications. In addition to preparing and prosecuting patent applications, he also assists clients with trademarks and copyrights and also provides consultation in invention related areas such as prototyping, marketing, and engineering. Although he does not litigate in court, often he can intervene in a matter with a goal of resolving any potential conflict before expensive litigation is necessary.



Peter is an honors graduate of the Florida State University, College of Law in Tallahassee and the University of South Florida, College of Engineering.

Peter first joined Rotary as a member of the Tallahassee Northside Club. After moving to Niceville, he joined the Niceville-Valparaiso Rotary Club (2002) and has served as club president twice. Under his leadership as President during 2016-2017 his club earned both the Presidential Citation and the Governor's Citation. Peter has completed RLI 1 & 2 and is a Paul Harris Fellow.

In January Peter and his son Christopher traveled to India to participate in a Polio National Immunization Day. Today he will share their adventures with our club.

Christopher is a student at Niceville High School. If his school schedule permits, he will join Peter for the program.

The next set of supplemental immunization days is planned for February 8 across 24 provinces.
