Our very own Dr. Scott Smith will speak to us today.

In June of this year, Scott, along with his friends and partners Drs. Shawn and Sara Leatherman, formed

Suncoast Healthcare Professionals. Scott was born and raised in Tampa Florida. After graduating High School, he joined the Army in 1990 and was sent to Fort Sam Houston and trained as a combat medic and surgical assistant assigned to an infantry unit at Fort Benning, GA. He spent a few years in the Army and went from active duty to the Army reserves, joining a hospital unit while attending college in Tampa. While actively drilling in the reserves, Scott worked with ophthalmologists at Saint Joseph Hospital on their surgical trauma team for five years.

Scott moved to Kansas City, MO in 1997 to attend Chiropractic school at Cleveland Chiropractic College. Dur-

ing Chiropractic College he belonged to a combat engineer unit as a medic with the rank of Staff Sergeant in the Missouri Army National Guard. In 1999 he took a semester off and attended Officer Candidate School (OCS) commissioning as a Second Lieutenant branched aviation and was sent to flight school at Fort Rucker, AL. While in flight school Scott was trained on the OH-58A/C Kiowa helicopter and then the AH-64A Apache. After flight school he returned to Missouri assigned to 1-135th Aviation Battalion where he was designated as B company platoon leader, promoted to



First Lieutenant and assigned as the Battalion S-4 Logistics Officer. Scott was then promoted to Captain and assigned Company Command position for A company 1-135th AVN BN. While continuing his military career in the National Guard, he completed his Chiropractic training and graduated in December of 2002. After graduation Scott moved to Houston, TX to work for a large healthcare group and then eventually moved to the Panhandle.

Scott is active in many professional organizations, and in his free time enjoys scuba diving and fishing with fellow Rotarian and friend Jeff Hooten.
