Today's Guest Speaker: Honorable Pat Hollarn Okaloosa County Supervisor of Elections



Today's guest speaker is our very own Rotarian, Supervisor of Elections, Pat Hollarn. Pat has resided in Okaloosa County since 1971 and has served as Supervisor of

Elections since 1988. Her tenure in office has been marked by great advances in technology, from the introduction of the first PC in the office to participating in pilot programs on internet voting.

During her years of service as Okaloosa County's Supervisor of Elections, Pat has upgraded the county's voting system to its current Diebold Accu-Vote system blended with the TSX touch screens for disabled voters, and devotes a great deal of time and effort to voter education. Even before "Motor Voter," countywide awareness programs increased voter registration greatly. Her introduction of KIDS VOTING, later revised to KIDS VOTE, TOO, has been very successful in training students to be voters for life.

Pat has a B.A. from the University of New Hampshire and has completed Graduate work at New York University, St. Mary's University, San Antonio TX, and Florida Center for Public Management at FSU. Pat has been designated as a Certified Supervisor of Elections since 1991; only the second Supervisor of Elections in Florida to be nationally certified by The Election Center.

Pat is the past president of the Florida State Association of Supervisors of Elections, having served in many other offices as well. In addition, she has been a member of the National Task Force on Election Reform since 2001, working closely with congressional staff as well as other election administrators on election laws. She testified on several issues in Governor Bush's Task Force on Election Reform in 2001, and in December 2002 was appointed as one of four Supervisors of Elections in an advisory panel to the Governor's Task Force II on Elections. She is also a member of the International Association of Clerks, Recorders, Election Officials and Treasurers (IACREOT).

Pat has many civic and community affiliations to her credit including: Member of Crestview, Fort Walton Beach, Niceville-Valparaiso and Destin Chambers of Commerce, Past Vice-President of Government Affairs in Fort Walton Beach Chamber of Commerce, and Board of Directors, Past Secretary, Treasurer, and Military Affairs Chairman in Crestview Chamber of Commerce, and also a member of its Board of Directors.

Pat is married to Tom Hollarn, retired AF pilot and current Lockheed Martin flight simulator instructor, for 46 years. They have three daughters, six grandchildren, and two friendly Dobermans. As a former music teacher, she especially enjoys her piano, also NY Times Sunday crossword puzzles, working out, and reading lots of newspapers.
