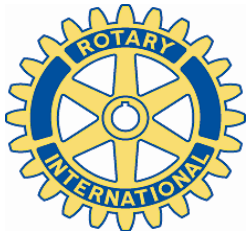

### How to make up a missed meeting

A club member must attend or make up at least 50 percent of regular club meetings in each half of the year. Any missed meetings must be made up within 14 days of a regular meeting. If traveling, club members are encouraged to visit clubs in the new area to make up a missed meeting. Check the *Official Directory* or use the [Club Locator](#) to get meeting and contact information. Be sure to call or e-mail before you show up for a meeting.

Another option is to participate in an interactive activity on a [Rotary e-club website](#). Rotary e-clubs are Rotary clubs that meet online. Effective 1 July 2010, Rotary e-clubs are officially a part of Rotary International, following a six-year pilot project. Other than meeting online to conduct Rotary business, Rotary e-clubs are essentially the same as other Rotary clubs: they conduct service projects, support The Rotary Foundation, and enjoy fellowship among members. Rotary e-clubs follow the same guidelines and procedures as other clubs.

For business, professional, and community leaders who are unable to attend a weekly meeting in person (due to physical disabilities, location constraints, or busy schedules), the e-club option offers the opportunity to be part of Rotary. The main distinction between Rotary e-clubs and Rotary clubs is in meeting format. While each e-club is assigned to a district, members can come from any country or geographical area where Rotary maintains a presence. Also, e-clubs must meet a number of technical requirements, such as a dedicated website, private sections of the website that only members can access, and online financial transaction systems for collecting dues payments.

### Rotary Leadership Institute (RLI)

The Rotary Leadership Institute (RLI) is a multi-district, grassroots leadership development program of member districts organized into regional divisions in various parts of the world.

RLI is not an official program of Rotary International and is not under its control.

RLI seeks to have Rotary Clubs in its member districts identify those Rotarians who appear to have the potential for future club leadership (not necessarily as club presidents) and provide those so identified with a quality education in Rotary knowledge and leadership skills so important in voluntary organizations.

The Sunshine Division of RLI will offer Courses 1, 2 and 3 on January 21st in Tallahassee. The courses must be taken in order and each one takes approximately seven hours to complete. Each course costs \$95 and the club will pay tuition for the first five FWB Rotarians who sign up. For more information, see the RLI website at <http://www.rli-training.org>.
